- · Rigorous screening & comprehensive medical evaluations, including extended genetic testing

- · Option to be known or anonymous

#### Medical Process

- $\cdot$  Egg retrieval & embryo creation typically take place in the U.S.
- · PGS/CGH testing (Preimplantation chromosomal screening)
- · Embryo transfer performed at a top clinic in California
- · Option to transfer two embryos (one from each biological father)

#### Legal & Post-Birth Process

- · Agreement signed between intended parents & surrogate with U.S. attorneys before embryo transfer
- $\cdot$  Court order issued to establish intended parents' legal parentage at birth or shortly after
- · Baby eligible for an American passport under existing regulations
- · Intended parents typically stay in the U.S. for 3-4 weeks after birth to complete the baby's local documentation

- · Post-birth process ensures both parents are listed on the birth certificate (for heterosexual couples) or only the biological father (for gay couples & singles), with no mention of the surrogate
- · Intended parents typically stay in Mexico for about 6-8 weeks after birth to complete the baby's local documentation

- · Genetic matching between intended parents & selected donor available
- · 100% anonymous egg donation

#### Medical **Process**

- · Egg retrieval & embryo creation take place in Armenia
- · Chromosomal screening (PGS/CGH) available
- · Embryo transfer conducted at a fertility clinic in Armenia
- · Option to transfer two embryos (subject to medical approval)

#### **Pregnancy Monitoring**

- · Monitored at the fertility clinic

- · Intended parents receive medical updates through Tammuz Family

#### Legal & **Post-Birth Process**

- · Agreement signed between intended parents & surrogate with a local attorney before or after embryo transfer
- · For heterosexual couples: Both parents are listed on the birth certificate, with no mention of the surrogate
- · For single parents: Only the biological intended parent is listed on the birth certificate
- · A DNA test is conducted to confirm the genetic link between the baby and the intended parent and no genetic connection to the surrogate
- · Intended parents typically stay in Armenia for about 5 weeks after birth to complete the baby's local documentation

- Existing Embryos (Own Embryos): From USD \$71,000

- PGS/CGH testing (Preimplantation chromosomal screening) available upon the intended parents' request
- · Embryo transfer conducted at a fertility clinic in Georgia
- · Option to transfer two embryos (subject to medical approval)

#### Gender Guarantee

· Not available

#### Not Georgian surrogates, only women coming from neighboring countries

- · Ages 21-42
- · Healthy pregnancy and birth history
- · Medical and psychological screening
- · Criminal background check
- · Mediated communication between the intended parents and the surrogate

#### Pregnancy Monitoring

- $\cdot$  Monitored at the fertility clinic
- · Follows a strict, predefined medical protocol
- · Intended parents receive medical updates through Tammuz Family

#### Legal & Post-Birth Process

- · An agreement is signed with the assistance of a local attorney between the intended parents, the surrogate, and the egg donor (if applicable) prior to the embryo transfer
- · Post-birth process to have both parents listed on the birth certificate, with no mention of the surrogate
- · Intended parents typically stay in Georgia for about 5 weeks after birth to complete the baby's local documentation

- · Self-Extraction: From USD \$58,000


